6. Collection, use and disclosure of personal information

Privacy and Data Protection Act 2014

The Department of Environment, Land, Water and Planning (DELWP) is committed to protecting personal information provided by you in accordance with the principles of the Victorian privacy laws. The information you provide will be used to monitor compliance with licence conditions and to provide information about any changes to legislative requirements. Your contact details may also be used by DELWP or its contracted service providers under confidentiality agreements to survey you about your experience with DELWP or to seek feedback related the keeping of wildlife. A licence may not be issued if the information required is not provided. The information you provide will also be made available to any authorised law enforcement agency.

7. Declaration by Applicant

I understand that there are penalties for making a false declaration and that any licence issued as a result of a false declaration will be cancelled, and may affect my eligibility to keep wildlife in the future, and that all details provided by me on this form are true and correct. I also consent to the collection, use and disclosure of my personal information for the purposes described in Part 6.

In Victoria, Wildlife Licences and authorisations are issued under the *Wildlife Act 1975* and the *Wildlife Regulations 2013*.

The holder of a Wildlife Licence, permit or authority must notify the Secretary within **10 business days** of any change of name or address provided to the Secretary in relation to the licence, permit or authority.

A wildlife licence cannot be transferred to another person. If you hold wildlife under a wildlife licence and want to transfer it to another person, that person must first have the appropriate wildlife licence.

If amending personal information (Parts 1 to 4) only, post or email the completed form to Wildlife Licensing at the address below.

If you are applying to upgrade your licence you will need to include a cheque or money order for the fee payable. Payment should be made out to "Department of Environment, Land, Water and Planning".

Licence Holders under 18 years of age seeking an Advanced Wildlife Licence for the purposes of keeping venomous snakes must include documentary evidence of competency in the safe-handling of venomous snakes and the signature of their parent or guardian.
