

## Program – general

### How much funding is available?

In the 2019/20 round of Wildlife Rehabilitator Grants a total of \$200,000 is available for wildlife rehabilitators in Victoria.

Grants to individual wildlife rehabilitators are capped at \$2,000 per applicant.

An additional \$500 is available (\$2,500 in total) to eligible rehabilitators to subsidise the cost of approved personal protection equipment for fire related activities. Rehabilitators will have successfully attended and completed one of the 'Support wildlife response activities (fire)' courses conducted by DELWP to be eligible for this additional funding.

Applicants who received this fire PPE grant funding in the 2018/19 are ineligible for the additional \$500 this year.

The amount granted may be less than this depending on the purpose for which it is to be used, the amount sought, the number of applications received and how well the application meets the assessment criteria.

### Why does DELWP provide funding to rehabilitators?

The Victorian Government recognises the skills and efforts of Victorian wildlife rehabilitators, and the importance and value of the work they do to rehabilitate wildlife in need.

We also recognise the substantial financial and time contribution that wildlife rehabilitators voluntarily provide for wildlife.

This grant provides financial assistance to help wildlife rehabilitators to operate their wildlife rehabilitation facilities and build their capability and knowledge.

### Can I decide how to use funding?

You can decide what items (equipment, infrastructure and training) to apply for in the application form. Ensure you only choose eligible items, as detailed in the Guidelines.

If your grant is approved, then grant funds can only be used on the approved budget items and activities. This will be specified in your Letter of Offer and the signed Funding Agreement (contract) for the grant.

During your project if you realise that you need to change how to use the funding, you can contact the Community Programs Team at [enviro.grants@delwp.vic.gov.au](mailto:enviro.grants@delwp.vic.gov.au) to request a funding variation.

### How long do I have to complete the project?

You will need to complete your project and all approved purchases and activities by 30 June 2020. A completion report and evidence will be due 31 July 2020.

### Why do I need the property owner's consent for my project?

You will need to demonstrate that the property owner supports your activities as infrastructure including enclosures and aviaries are significant items to install on someone else's property.

DELWP would like to see long term benefit from the infrastructure funding we provide.

Written approval to install infrastructure on someone else's property is required at the application stage and is an eligibility requirement.

### Can two people at the same address apply for a grant?

No. Only one grant per address.

## Application period and submission

### When do applications open and close?

**Applications open:** Friday 2 August 2019

**Applications close:** 5.00pm\* on Monday 2 September 2019

\*Please note that this is an electronic system that automatically closes so applications must be submitted **PRIOR** to 5.00pm on Monday 2 September 2019 to be eligible.

**Late applications will not be accepted.**

### How can I apply?

From this web page, click on the **'Start New Application'** button.

You will then be asked to enter your account. If you don't have one, click on the **Create an Account** button.

Note your username (email) and password for future reference. Try to choose an email that will not change into the future – because over time your account will record your grant history for you.

\*Mandatory questions are marked with an Asterix and the system won't let you continue until they are answered. Also makes sure you have provided all necessary documents in the Supporting Documents section.

Save your work often. To return to a saved draft application, click on the **'Access Saved Application'** button. You can print a copy of your application to check before submitting.

Make sure your application is **submitted before 5:00pm on Monday 2 September 2019**. After that time the system will not let you submit the form.

You will receive an **application number** when you submit an application online. **Please quote this number in all communications** with the department relating to your application.

### What is the training template?

The training template is a simple table in which you can list and build upon the training you undertake over time. It is optional, and you could use a similar list you may already have.

In the online form you can either enter your training details into the training section **or** attach the training template in the Supporting Documents section.

Over time add to the list of training and conferences you have attended/completed into the template and attach each round.

## Frequently Asked Questions

### If I need to make a change to my application form, what do I do?

Please ensure that you carefully read and check your application form before submitting. Use the **Preview** button to check you have completed all relevant sections, that all the information is true and correct and that you have attached required supporting documents.

In the unlikely event that you do need to make a change *after* you have pressed submit:

- if more than one day before the end date - phone Victorian Grants Information Line 1300 366 356 (Mon-Fri 8.30 – 5.00) or email [enviro.grants@delwp.vic.gov.au](mailto:enviro.grants@delwp.vic.gov.au).
- If less than one day before the closing time – submit a *new* application form by going to <https://www.wildlife.vic.gov.au/grants/wildlife-rehabilitator-grants> and click on the ‘**Start New Application**’ button. Please note in the feedback section that it is a corrected version, so that we can disregard your previous/incorrect application.

### What if I can't apply online?

We encourage everyone to try to use the online form. However, if this presents an overwhelming challenge, we do not want technology to prevent you from applying for this grant.

### Will receipt of my application form be acknowledged?

Receipt of your application will be acknowledged via a Grants Online system generated email to your registered email address.

### I have submitted my application form, now what happens?

Applications will be assessed against the funding criteria and recommendations will be provided to the Minister for Environment and Climate Change for approval. All applicants will be notified of the outcome of their application. Please note that notification could take some time by the time assessment is undertaken and approval is sought.

## Eligibility

### Who is eligible to apply?

Individual wildlife rehabilitators in Victoria who:

- Have held a current permit as a shelter operator or foster carer for at least two (2) years.
- Are undertaking their rehabilitation activities from their registered location.
- Are the only person applying from a given address. (i.e. only one grant per address)
- Have no convictions for fraud or convictions under the Wildlife Act 1975 or the Prevention of Cruelty to Animals Act 1986 during the past ten years.
- Have submitted all Completion Statements for previous funding from this program.
- Have the consent of the property owner.

**Note:** Funds are for the successful grant recipient to use for their own registered place. i.e. not pass to another person or place.

### Who is not eligible to apply?

Any person who:

- Is not an authorised shelter operator and foster carer with a current licence.
- Does not have minimum two (2) years' experience as an authorised shelter operator or foster carer in Victoria.
- Has convictions for fraud or convictions under the Wildlife Act 1975 or the Prevention of Cruelty to Animals Act 1986 during the past ten years.
- Is applying from the same address as another applicant. (i.e. only one applicant can apply for this grant at a given address)
- Has not submitted all Completion Statements for previous funding under this program.
- Does not have the consent of the property owner.
- Does not provide clear and readable shelter records.

### Wildlife carer licences expired on 30 June 2019. Am I still eligible for funding after then?

You must have renewed your shelter operator or foster carer licence if you wish to remain eligible for a 2019/20 Wildlife Rehabilitator Grant. Please provide your licence number when applying so we can confirm you are still an authorised carer until 30 June 2020.

### Why do I have to have 2 years minimum experience to be eligible to apply for a grant?

Rehabilitation of animals can be time consuming and resource intensive. The 2 years minimum requirement is to ensure that you are committed to being a rehabilitator, have undertaken some training and have the support around you to be successful.

## Funding Items

### What can I spend the funding on?

Grants will be provided to:

- Attend training/education. Please note that attending the Australian Wildlife Rehabilitator Conference 2020 is ineligible for funding in this round because it occurs in the next financial year.
- Purchase general infrastructure and other equipment relevant to wildlife rehabilitation to assist with the operation of your facilities (including, but not limited to cages, enclosures, pens, fencing)
- Purchase other equipment relevant to wildlife rehabilitation including Personal Protective Equipment (not for fire response activities)
- Purchase consumable items (e.g. feed, petrol and medical supplies), up to \$1,000.

### Can I apply for one item category only?

Yes. However, funding for consumable items such as feed, petrol and medical supplies is limited to \$1,000.

### Can I apply for an item that is not listed in the guidelines?

Yes, providing it's not listed as an ineligible item. The Assessment Panel has the discretion to approve any action or activity determined to be an appropriate or suitable use of the funds.

### When do items have to be purchased?

Items must be purchased between 1 July 2019 and 30 June 2020. Please ensure you keep receipts, as they may be requested.

### When do I have to complete my training/attend courses or conferences?

Training, course and conference attendance must be between 1 July 2019 and 30 June 2020.

### What is the additional \$500 funding for?

The additional \$500 (ex GST) funding amount for approved fire personal protective equipment (PPE) is for those rehabilitators that have successfully completed the 'Support wildlife response activities (fire)' courses conducted by DELWP. The courses were held at the below locations;

This PPE must meet minimum safety standards, and as such can only be purchased through DELWP. Successful recipients will receive advice on how to order, pickup or have posted their items from DELWP Altona.

## Frequently Asked Questions

### Can I apply for \$2,000 and the additional \$500?

Yes, however you must have successfully completed the 'Support wildlife response activities (fire)' course. A check will be undertaken during the eligibility stage to ensure all rehabilitators have met these minimum requirements. Applicants that were successful in receiving the additional \$500 in the 2018/19 round are ineligible to apply for this item again in the 2019/20 round.

### What can I purchase with the additional \$500?

Rehabilitators can only purchase the following items up to the amounts indicated.

What fire PPE will be funded?	
Item	Maximum amount \$
Boots	\$230
Overalls	\$180
Helmet	\$50
Socks	\$15
Goggles	\$15
Mask	\$10

This can only be for approved brands supplied by DELWP. Details on how to order will be provided to successful applicants.

### What is not eligible for funding?

Grants can only be used for equipment primarily for wildlife care and rehabilitation. Funding will not be available for utility costs such as electricity, water, gas and sewerage bills. Vehicles, boats, computers and communication devices, such as mobile phones, will not be considered for funding.

PPE for use while handling wildlife is allowed under the Other Items category, however PPE for fire response activities must be applied for in a separate section within the application form.

### What if I want to apply for an item or training course and I'm not sure it's eligible for funding?

Any item/training not specifically stated as ineligible, will be assessed on merit. This will be determined by how relevant the item/training is to wildlife rehabilitation.

Please note that if the item you apply for is deemed ineligible, this will not affect the rest of your application if you separately list any other items/courses on your application.

### Why isn't the 2020 Australian Wildlife Rehabilitators Conference eligible?

The **2020 Australian Wildlife Rehabilitation Conference (AWRC)** will be held in August 2020 in Darwin. Grant activities and budget items in the WRG 2019/20 round are to be actioned and spent in that financial year, and therefore this item is not eligible.

We recognise that the conference is often reported by WRG recipients to be a very valuable opportunity for rehabilitators to learn and meet others.

If Wildlife Rehabilitator Grants are provided in 2020/21 then it is likely that 2020 Australian Wildlife Rehabilitation Conference (AWRC) will be an eligible item. If WRG guidelines remain consistent, then it would also be likely that there is a cap of \$300 per recipient and that flights, accommodation and food would not be eligible.

## Frequently Asked Questions

### Assessment

#### How do I know the assessment process is fair?

It is important that all participants in the program are treated equitably and fairly, and that participants retain confidence in the integrity of the assessment process. To achieve this, DELWP has a process in place to ensure transparency and accountability.

#### What are the Assessment Criteria?

An Assessment Panel will use the criteria below to assess each application. Applications must meet a passable standard in each criterion to be considered for funding.

In addition to these questions, previous history such as non-completion of projects, overdue reports, and outstanding compliance issues may be considered as part of the assessment.

Assessment Criteria	Weighting	Description
Project alignment with the grants program	35%	<p>You will be asked in the application form to describe how your project will benefit wildlife welfare through:</p> <ul style="list-style-type: none"><li>• increased knowledge of and/or skills in the care of wildlife</li><li>• improved facilities to treat, house and rehabilitate wildlife for release</li><li>• improved standard of wildlife care you provide for specialist species or threatened species.</li></ul> <p>Your application will be assessed on your response to this question and how it relates to the budget items you are requesting.</p>
Project need	40%	<p>Your application will be assessed on the nature of items asked for, what wildlife rehabilitation issue will this project support and whether you have received grant funding under this program in the past two years. Preference will be given to those rehabilitators that have not received funding in the last two years.</p> <p>Applications that provide quotes, drawings and evidence to support their requested items, will be scored higher than those applications that do not supply this supporting information.</p>
Experience/knowledge of rehabilitator	25%	<p>Your application will be assessed on the number of years' experience as a DELWP authorised rehabilitator, whether you have handled threatened species in the past, the number of wildlife you handled between 1 July 2018 and 30 June 2019 and how many wildlife courses have you undertaken previously.</p>

**Note:** Wildlife Rehabilitator Grants are competitive grants and are scored according to these assessment criteria. If more funds are requested than what is available, not all applications that meet the minimum criteria will be funded.

### Contracts and funding

#### When will the funds be in my nominated bank account?

Funding Agreements will be forwarded out to you once an announcement has been made by the Minister's office. Once you return the signed funding agreements with all your payment details, the payment will generally be processed within 4 weeks.

#### When do all the items need to be purchased and works need to be completed?

You will need to complete your project by 30 June 2020. This means you need to purchase items, undertake training, attend courses and build enclosures by 30 June 2020.

#### What happens if I want/need to change what I spend my grant on?

Once you enter a funding agreement, any changes to the budget, activities and items will need to be approved by DELWP. You will need to contact DELWP in the first instance before submitting a variation request. Any variations will be assessed against the funding criteria specified in the guidelines.

#### Do I need an ABN to apply for this grant?

Applicants should consult the Australian Taxation Office or seek professional advice on any taxation implications that may arise from this grant funding.

Applicants do not need to provide an ABN to apply for this grant. If you are successful and do not have an ABN, we will send you a '*Statement by a Supplier*' form which you will need to complete and return to us.

#### Should I include GST in my costings?

Yes. For this grant, DELWP does not pay GST in addition to the total grant amount (regardless of whether you are GST registered or not). Therefore, it is important that you provide the total costs (including GST) in your grant application.

### Further Information

#### If my application is unsuccessful, can I ask for feedback?

Yes, and we encourage you to ask for feedback. The announcement letter will include contact details on who to contact for feedback.

#### How do I Acknowledge the Victorian Government's support?

Successful applicants are expected to acknowledge the Victorian Government's support and promotional guidelines (<https://www2.delwp.vic.gov.au/grants>) will form part of the funding agreement. Successful applicants must liaise with the departmental program area to coordinate any public events or announcements related to the project.

#### When will I hear whether I have been successful?

The Department of Environment, Land, Water and Planning (DELWP) anticipates that announcements will be made by the end of October 2019.
