1. What is the Wildlife Rehabilitator Grants program?

The Victorian Government's Wildlife Rehabilitator Grants (WRG) program provides funding to support authorised wildlife shelter operators and foster carers to rehabilitate sick, injured or orphaned wildlife so animals can be released back to the wild.

The objectives of the program aim to help wildlife rehabilitators:

- Improve the standard of wildlife care they provide.
- Improve their facilities to treat, house and rehabilitate wildlife for release.
- Increase their knowledge/skills in the care of wildlife.

In Victoria, sick, injured or orphaned wildlife can only be rehabilitated by a wildlife shelter operator or foster carer who is authorised under section 28A of the *Wildlife Act 1975* (Wildlife Act). Wildlife rehabilitators are subject to strict conditions. The mandatory requirements that they must meet are set out in the Wildlife Shelter and Foster Carer Authorisation issued under the Wildlife Act.

These conditions enforce the minimum standards required for the humane treatment and successful rehabilitation of wildlife in care. 2. How much funding is available?

The total amount available for the Wildlife Rehabilitator Grants 2022-23 round for wildlife rehabilitators is \$230,000. Each applicant can apply for up to \$3,000.

The amount granted may be less than this depending on the purpose for which it is to be used, the amount sought, the number of applications received and how well the application meets the assessment criteria.

Note: preference will be given to shelter operators or foster carers who have not received any WRG funding support in the last 2 years.

3. Who can apply?

Individual wildlife rehabilitators in Victoria who:

- Hold a valid authorisation issued by the Department of Environment, Land, Water and Planning (DELWP) as a shelter operator or foster carer with at least two (2) years' experience.
- Are carrying out their rehabilitation activities from their registered location.
- Are the only person applying from a given address.
- Have no convictions for fraud or convictions under the *Wildlife Act 1975* or the *Prevention of Cruelty to Animals Act 1986* during the past 10 years.
- Have submitted all Completion Statements for previous funding from this program.
- Have the consent of the property owner.
- Are carrying out activities in compliance with all public health measures and requirements in relation to COVIDSafe Settings.

Note: Funds are for the successful grant recipient to use at their own registered place i.e., not pass to another person or place.

4. Who can not apply?

Any person who does not meet the above criteria is ineligible to apply for this grant.

Note: Only one applicant can apply for this grant at a given address.

5. When is the eligible purchase period and how long do I need to keep my receipts?

Eligible items that are purchased and paid for between 1 Oct 2022 and 30 September 2023 can be funded.

Note: Please ensure that you keep all receipts for a minimum of five (5) years from the completion of your project, as they may be requested if you are audited.

6. What type of Education and Training is eligible?

Competency-based training delivered by a registered training organisation or any other approved training to be held in between 1 October 2022 to 30 September 2023.

The Victorian Wildlife Rehabilitation Guidelines will be released later this year. Shelter operators and foster carers are encouraged to register and participate in free on-line seminars being promoted via 'Together for Wildlife.'

7. What are the requirements when purchasing general infrastructure and equipment?

You may apply for grant to purchase general infrastructure and equipment that helps you with your rescue and rehabilitation of wildlife.

If you are planning to purchase equipment or infrastructure with value of more than \$500, it is a requirement that you provide a quote and design dimensions for the proposed infrastructure to be constructed or quote for equipment in your application.

Ensure dimensions for enclosures are consistent with the *DELWP Wildlife Shelter and Foster Carer Authorisation Guide, July 2019* (Condition 14 and Appendix 2).

Note: Emergency Response Personal Protective Equipment (PPE) is mandated by DELWP, however, this year it is not an eligible item for funding. If you have any queries, please contact the Wildlife Emergency team at wildlife.emergencies@delwp.vic.gov.au

8. What type of Consumable items can I apply for?

Consumable items (capped at \$1,500 as part of the maximum grant allocation), such as feed, petrol, veterinary fees and veterinary supplies.

Funding for other items (other than those excluded in Appendix 2) may also be considered by DELWP on merit, providing there is enough information in your application to justify the purchase.

See Appendix 1 for detailed information on eligible items.

9. What will not be funded?

Funding will not be provided for a range of activities and items not consistent with the WRG program, including:

- Utility costs such as rates, electricity, gas, and sewerage bills.
- Vehicles including all types of trailers, boats, and ride on mowers.
- Chainsaws, mulchers, freezers, and generators.
- Infrared and motion-sensing surveillance cameras, radio telemetry, Schedule 4 and 8 capture chemicals.
- Emergency Response PPE that is mandated by DELWP.
- Firearms including captive-bolt guns and darting related equipment, purchase, hiring and training courses. Gun safes, bullets and darts are not permitted.
- Any illegal activity.
- Purchase of goods for competitions, prizes, giveaways, vouchers, or alcohol.
- Legal fees or lobbying activities.
- Education campaigns that could be considered political in nature (whole or part).
- Promotional or marketing material (e.g., stickers, magnets, flyers, etc).
- Computers, laptops, tablets, and mobile phones/smartphones.
- Insurance (vehicles, memberships, house, and property, etc).
- Any other activity or item determined by the assessment panel through the assessment process to be an inappropriate or unsuitable use of the funds.
- Any item not permitted by the *DELWP Wildlife Shelter and Foster Carer Authorisation Guide, July 2019*.

Note: If an item in your application is deemed ineligible this will not affect the rest of your application. However, it will decrease the amount of your grant, so for your best result ensure you choose eligible items.

See Appendix 2 for detailed information on ineligible items.

10. How do I apply?

Applications are to be submitted online using the **Grants Online** portal.

Apply online at:

From this web page, click on the **'Start New Application'** button.

You will be asked to enter your account. If you don't have one, click on the **Create an Account** button.

Keep a record of your username (email) and password for future reference. Try to choose an email that will not change in the future because over time your account will record your grant history.

To return to a saved draft application, click on the **'Access Saved Application'** button.

You will receive an **application number** (APPL-XXXXX) when you submit an application online. **Please quote this number in all communications** with the department relating to your application noting that this number will change if you are successful in obtaining a grant.

11. How to complete the online form

- a. Start early to give yourself enough time to read the guidelines carefully, get help if needed, check and submit your application on time.
- b. Refer to the *DELWP Grants Online Information Sheet for Community Users* link provided on the web page above.
- c. Use **Google Chrome** rather than Internet Explorer which doesn't perform as well.
- d. *Mandatory fields are marked with an **Asterisk***. The online form won't let you continue unless these questions are answered.

Use the navigation bar to get to the page you want or use the **Next Page** or **Previous Page** buttons (not the browser backwards/forwards arrows).

Supporting documents

In the Supporting Document section of the online form, attach all required documents and any others you think would support your application.

Note that:

- Supporting documents must be in an acceptable file type, such as Word, Excel, PDF, or JPEG. The maximum file size for each file is 10MB.
- If you have documents to submit that cannot be attached to your online application, you can email them to enviro.grants@delwp.vic.gov.au quoting your application number. Attach all documents to one email, zipping the files if required.

Submit your online application form

Check your application first by either pressing the **'View as PDF'** button or navigating using the navigation pane or Next Page or Previous Page buttons.

When you are confident your application is complete and correct, press the **'Submit'** button.

Make sure your application is submitted before **1.00pm Tuesday 6 September 2022**.

Late or incomplete applications will not be considered.

12. What supporting documents need to be provided?

To assist the assessment panel and grant team, please provide any information that would support your application, and in particular:

- Quotes for training courses, infrastructure, or any other large items (greater than \$500).
- Designs for enclosures or infrastructure.
- Up-to-date shelter 2021-22 records.
- Your training register - a simple template that you can fill out and add to over time at wildlife.vic.gov.au/grants/wildlife-rehabilitator-grants. You can either list your training in the online form or attach this document (or something similar) in the Supporting Documents section of the application form.
- Written consent from the property owner to undertake the activity.

13. How will applications be assessed?

First, applications will be checked for eligibility to make sure that the applicant and their activity are eligible for funding. After that eligible applications will be assessed using the criteria listed below. Each criterion is

given a percentage weighting to indicate its relative importance in the assessment process. Applications should address all relevant criteria.

Note:

- a) Eligibility checks include uncompleted past projects, overdue grant reports, and current compliance notices.
- b) Wildlife Rehabilitator Grants are competitive grants and are scored according to these assessment criteria. If funding demand exceeds the total funds available, funding preference will be given to higher scoring applications.

14. What happens after applications close?

Assessment

All applications will undergo an eligibility check. Eligible applications will then be assessed by an assessment panel using the criteria listed in Section 9. All decisions are final and are not subject to further review.

Notification

Successful and unsuccessful applicants will be notified in writing via email. Unsuccessful applicants can ask for feedback on their application.

Please be patient as it can take some time to assess all grants before you will be notified. It is anticipated (but not guaranteed) an announcement of successful recipients will occur between December 2022 and January 2023.

Contracts and payment

If successful, DELWP will send you the Victorian Common Funding agreement via Adobe Sign for you to sign electronically. DELWP will counter-sign the agreement and you will receive a fully signed contract via email.

If it takes more than **4 weeks** for DELWP to receive your signed contract and any specified documents, DELWP may withdraw and reallocate the funding.

A single upfront payment will be paid into your nominated bank account within 3-4 weeks of the signing of the agreement by both parties. DELWP will provide a supplier details form for you to complete prior to payment.

15. What are the Key Dates?

Applications open:	4 August 2022
Applications close:	1:00 pm Tuesday 6 September 2022
Applicants notified (tentative):	December 2022 – January 2023

16. What are the funding conditions?

Funding agreements

Successful applicants must enter into the Victorian Common Funding agreement with DELWP. It is recommended that applicants review the terms and conditions before applying. Information about the Victorian Common Funding Agreement is available at vic.gov.au/victorian-common-funding-agreement.

The activity does not include using the Funding for political campaigning or advocacy activities for political parties.

Payments

A once-off upfront payment will be made when the funding agreement has been signed by both parties.

Monitoring and Reporting

Grant recipients are required to comply with project monitoring and reporting requirements as outlined in the funding agreement. This includes the submission of a completion (including acquittal) report.

17. What other information do I need to know?

Tax implications

Applicants should consult the Australian Taxation Office or seek professional advice on any taxation implications that may arise from this grant funding.

Successful applicants without an ABN will need to provide a completed Australian Taxation Office form 'Statement by a Supplier' so that no withholding tax is required from the grant payment.

GST: If you are registered for the Goods and Services Tax (GST), where applicable we will add GST to your grant payment and provide you with a recipient created tax invoice.

Acknowledging the Victorian Government's support

Successful applicants must liaise with the departmental program area to coordinate any public events or announcements related to the project.
